

### **Family Enterprise USA Women's Business Owners Group**

The Family Enterprise USA (FEUSA) Women's Business Owners Group (The Group) is a bipartisan coalition of women business owners dedicated to highlighting and addressing the challenges faced by women-owned businesses in today's economy. The Group's mission is to amplify the voices of women entrepreneurs, foster collaboration, and advocate for policies that promote business, job creation and economic growth with Members of Congress in Washington, DC.

Women-owned businesses represent nearly 40 percent of all U.S. businesses – over 14 million businesses in total – and account for \$2.7 trillion in revenue. Women-owned businesses employ over 12.2 million employees nationwide. Notably, during the COVID-19 Pandemic, women-owned businesses added 1.4 million jobs to the U.S. economy.<sup>[1]</sup> Now more than ever, women-owned businesses deserve a seat at the policymaking table.

The Group will be comprised of women business owners who are passionate about sharing their experiences, challenges, and successes in entrepreneurship and working with stakeholders to create actionable solutions. The Group will engage directly with members of Congress, including members of the Congressional Family Business Caucus, to highlight the important role of women-owned businesses to the U.S. economy and discuss women-owned businesses in the context of broader family-owned business issues. The focus of the Group will include tax and economic issues, that affect women owned business and all family businesses.

The Group's activities will include hosting regional networking events, organizing educational seminars, attending the Congressional Family Business Caucus meetings in DC, and participation in FEUSA's webcast "The Voice of Family Business on Capitol Hill." Additionally, the Group will also participate in events and meetings with Members of Congress and constituents in Washington, DC, or in congressional districts across the country.

A Member should be a women who is a significant owner of a family-owned business. She should be interested in educating Members of Congress that shape legislative policies by participating in local meetings as well as Congressional Family Business Caucus meetings in DC.
